BUS RIDER AGREEMENT FORM

## Know your Bus Route and Stop time, be there 10 minutes before the stop time. Remember! Riding the School Bus is a Privilege, Nat a Right.

Transportation is a privilege extended to students in the School District. It is the responsibility of the driver and student(s) to do everything possible to make every route a safe ride.
The privilege of the student to ride the school bus is contingent upon continuous observation of the safety rules and acceptable behavior. The Bus Driver or Bus Aide may assign seats.

## RULES ON THE BUS

1. Use "Classroom voice" in the bus.
2. No eating or Drinking in the bus. (Water is ok).
3. Keep inside the window.
4. Follow Drivers Instructions / Use No Profanity.
5. Do not throw any objects in the bus or out of the window / Trash left on the bus.
6. No animals, insects or reptiles are allowed to be transported in the bus.
7. Remain seated and in the forward position / Keep your hands to yourself.
8. No: running, pushing, tripping, spitting or rudeness to others.
9. Glass containers cannot be transported on the bus.

## SEVERE CLAUSE / LOSS OF RIDING PRIVILAGE AND-OR RESTITUTION SOUGHT

1. No Tampering or destruction to components on the bus.
2. No Vandalism to the bus or seat upholstery.
3. No weapon of any kind.
4. No Gang intimidation or tagging, related.
5. No Fighting or threats of inflicting harm to others.
6. No Sexual misconduct or lewd acts permitted.
7. No Smoking "of Any kind"/ No Vaping / No chewing tobacco.
8. No Drugs or paraphernalia of any kind.
9. Threats of violence or harm to any person on or off the bus.

## Bus Conduct Report consequences.

Bus Conduct Referral Matrix
$1^{\text {st }} \mathrm{BCR}$ Parent/Guardian and Principal informed of BCR. Bus Agreement form is sent home electronically or with student. This form is to be read, reviewed and signed at home by student and parent or guardian. CONSEQUENCE: Student is assigned a seat for two weeks.
$2^{\text {nd }}$ BCR Parent/Guardian and Principal informed of BCR and acknowledgement of the Bus Agreement Form. CONSEQUENCE: Student is assigned a seat for 4 weeks minimum or permanently pending severity of in fracture.
$3^{\text {rd }}$ BCR Parent/Guardian and Principal informed of BCR and acknowledgement of the Bus Agreement Form. CONSEQUENCE: Student receives 7 school days suspension from all Bus privileges and permanent assigned seating upon return.
$4^{\text {th }}$ BCR Parent/Guardian and Principal informed of BCR and acknowledgement of the Bus Agreement Form. CONSEQUENCE: Student receives 30 school days suspension from all Bus privileges and permanent assigned seating upon return.

Additional infractions will merit at least 90 days suspension of ALL Bussing privileges.
We have read the Agreement and we understand the Bus Rules and the Consequences.
Return this form, signed, to the Bus Driver in the morning. Student will not be allowed to board the bus without it.
Form will be filed at Transportation.
